



Release of Liability; Waiver of Claims, Indemnity Agreement

Please Read Carefully Before Agreeing. By purchasing a Kidsworld Pass and signing the registration form, you acknowledge that you have read and agree to these terms

For Kidsworld Entertainment (BC) Ltd. (hereafter referred to as "Kidsworld"):

1. I understand and accept responsibility that I, the guardian, am responsible for my child at each event. I am the primary caregiver throughout all the events and activities associated with Kidsworld.
2. As parent or guardian of the attending child/children, I will ensure that we all abide by the rules and regulations imposed on the participants in the event. We will not endanger the safety of others or ourselves during this event.
3. I/We release any video or photos taken at events including online Zoom sessions by members, Kidsworld staff, event host staff or volunteers. They may be used for promotional material, including webpages and social media (Facebook, Twitter, Instagram). I am responsible for informing the photographer or Kidsworld Program Director Brian, if I/we wish to not be included in any promotional material.
4. There are risks and hazards inherent to all events and activities hosted by our partners. I acknowledge that as a result of these risks and hazards, the child/children and/or I, may suffer personal injury, even death, as well as property loss. I/We nevertheless freely and voluntarily assume the aforementioned risks and hazards and accordingly the child/children's participation in The Event shall be entirely at our own risk. We can choose to not participate in any activity that we do not wish to.

In registering the child/children for the Kidsworld program, I agree to waive any and all claims that I have, or may have in the future, against Kidsworld, or any of the host organizations, offered in the Kidsworld Calendar of Events, for any and all liability for damage, or injury, resulting from attending any Kidsworld Events/Activities, due to any cause whatsoever; and to hold Harmless and Indemnify Kidsworld as well as the host organizations.

This release is also intended to include all claims of my family members, estate, heirs, personal representatives or assigns. If I am under age 19, my parent or guardian, by agreeing, also consents to my release and he or she agrees that this release shall be binding upon him or her as my parent or guardian as to me and my estate, heirs, personal representatives and assigns. My parent or guardian also promises, to defend, indemnify and hold Kidsworld harmless, if I should repudiate this release after obtaining adulthood.

This Release Agreement, and any rights, duties and obligations, between the Member Family and Kidsworld or the Events/Activities, shall be governed by and interpreted solely in accordance with the laws of British Columbia and no other jurisdiction; and any litigation involving the parties to the Release Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia and no other jurisdiction.

NOVEL CORONAVIRUS (COVID-19) ACKNOWLEDGEMENT AND ASSUMPTION OF RISK

By purchasing a Kidsworld Pass, you acknowledge that you have read and agree to these terms.

I agree to follow and respect all rules put forth by Kidsworld and any host organizations in regards to COVID-19. I agree to wear a mask when instructed, and to stay six feet apart from others whenever possible. I and my family further acknowledge that Kidsworld and event partner organizations have put in place preventative measures to reduce the spread of the COVID-19.

I attest that:

- I and my family acknowledge the contagious nature of the Coronavirus/COVID-19 and that many public health authorities still recommend practicing social distancing.
- I further acknowledge that Kidsworld cannot guarantee that I or my family will not become infected with the Coronavirus/COVID-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, event staff, and other Kidsworld members and their families.
- I acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while attending Kidsworld Events.
- I and my family have not been diagnosed with Coronavirus/COVID-19 and not yet cleared as non contagious by provincial or local public health authorities.
- I and my family will not attend in-person Kidsworld Events if I am experiencing any COVID-19 symptoms nor if I have had COVID-19 symptoms in the last 14 days. These symptoms include, but are not limited to, cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I and my family will not attend in-person Kidsworld Events if I have travelled outside of Canada or in an area under a travel health advisory in the last 14 days.
- I and my family will not attend in-person Kidsworld Events if I have provided care or had close contact with any person with COVID-19 or with any person reasonably suspected of having COVID-19 or with any person who travelled outside of Canada in the last 14 days or with any person who travelled in an area under a travel health advisory in the last 14 days.
- I and my family represent and warrant to the Releasees that I have not been advised by the Government of Canada or the Government of British Columbia or my doctor or the British Columbia Ministry of Health website to self-isolate due to possible exposure to COVID-19.
- I and my family are fully aware of the risks and hazards with respect to COVID-19 inherent in my attendance at the Premises and participation in the activities of Kidsworld or any of the Kidsworld event host organizations. I freely and voluntarily agree to assume the risk with respect to COVID-19, including the risk of death, bodily injury or property damage, regardless of severity, that I (or my child/ward) may sustain as a result of my participation in the activities of Kidsworld or attendance at the host event premises, howsoever arising, including, but not limited to, the active or passive negligence of the Releasees.

I understand that I am giving up substantial legal rights by ordering a Kidsworld pass and signing the registration form, including the right to sue the Releasees. I acknowledge that I am signing this agreement freely and voluntarily and intend my signature to be a waiver and complete and unconditional release of all liability due to the negligence of the Releasees or, the inherent risks of participating in the activities of Kidsworld or while attending Kidsworld Events.
